Subject: Declaration Of Results, November 5, 2002 General Election: Measure W, City of Rancho Cordova and Election of Members of the City Council

Overview:

The Governing Board of a jurisdiction that places a contest on a ballot declares the official results of those elections after the Registrar of Voters issues a Certificate of Facts. The Sacramento County Board of Supervisors placed Measure W before the voters in the proposed City of Rancho Cordova at the General Election held November 5, 2002.

Recommendation:

That your Board declare that Measure W on the General Election ballot, November 5, 2002 was approved by the voters and that the following candidates were elected to the City Council of Rancho Cordova:

- Dave Roberts
- Linda Budge
- Ken Cooley
- Robert J. McGarvey
- David M. Sander

Fiscal Impact:

No fiscal impact

BACKGROUND:

A governing body may place a measure before the registered voters of the jurisdiction. Following the Official Canvass of the Votes, the Registrar of Voters issues a Certificate of Facts to that governing body, which declares the results of each contest it placed before the voters.

DISCUSSION:

Elections Code §15400 requires your Board to declare the results of any election contest under your jurisdiction. Your Board placed Measure W on the November 5, 2002 General Election, asking the voters in the proposed City of Rancho Cordova to decide whether to incorporate as a city. Voters were also asked to elect five candidates to serve on the new City Council if Measure W were approved.

The Question of Incorporation

Measure W required a majority vote of those casting ballots on the measure. It was approved by the following vote:

“Yes” votes – 9,097

“No” votes – 2,630

The voters approved the proposal to incorporate Rancho Cordova.

The Election of a City Council

Voters in the proposed City of Rancho Cordova were also asked to elect five candidates to serve as the new City Council of Rancho Cordova. The results of the election of the City Council would be certified only if the question of incorporation were approved. Twenty-one candidates qualified for election to the new City Council. Voters were asked to select any five of those candidates. The candidates elected to the City Council of Rancho Cordova are:

- Dave Roberts
- Linda Budge
- Ken Cooley
- Robert J. McGarvey
- David M. Sander

I have attached a copy of the Certificate of Facts for Measure W including the election of five Members of the City Council of Rancho Cordova.

CONCLUSION:

Your Board is required to adopt the results of each election contest under your jurisdiction.

Shall the order adopted on July 16, 2002, by the Board of Supervisors ordering the incorporation of the territory described in the order and designated in the order as Incorporation of Rancho Cordova, California (12-97) be confirmed subject to the terms and conditions including the annual payment from the City to the County of Sacramento, including the sharing of its revenue with the County of Sacramento and the Property Tax Revenue Agreement between the City and the County of Sacramento commencing in fiscal year 2003-2004 and terminating, as adjusted, no later than after the end of fiscal year 2033-2034; including authorization, as approved by the voters through this measure, for the City to continue to levy and collect within its territory the same general taxes, fees, charges, assessments and rates levied and collected by the County of Sacramento as of November 1, 2002; and further including approval by the voters through this measure of the Tax Sharing Agreement Between the County of Sacramento and the City of Rancho Cordova, as more particularly described and set forth in the order?
