## **RECOMENDATION**

This report is for information only, no action is required. Staff is working with interested parties to schedule a Public Workshop for early next year, as resources allow. The Workshop will consider the proposed policies. It is anticipated that the final policy recommendations will be presented to your Commission shortly thereafter.

#### **DISCUSSION**

Commissioner Tooker has requested that staff broaden the nature of the Open Space Workshop previously proposed to be held this evening.

#### **BACKGROUND**

**Open space lands are necessary for our quality of life and we must preserve and protect the land today so future generations may enjoy its physical and spiritual benefits tomorrow.** Notwithstanding the three plus years of extensive public outreach that your staff has completed, it may be of benefit to make a one more overture to interested parties regarding their input to the proposed policies. Completed outreach has included four public workshops, one each in Elk Grove, Galt, Herald, and Rancho Cordova. We have also discussed the draft policies with ECOS, the BIA, all of the city Planning Directors and the County of Sacramento Planning Director. The draft policies have been widely distributed via e-mail, as well as posted @ www.SacLAFCo.org.

## PUBLIC WORKSHOP

Your staff will issue a call for presentations to various speakers regarding their programs, such as The Nature Conservancy, Sacramento County Farm Bureau, Sacramento Open Space Conservancy, Stone Lakes National Wildlife Preserve, Sacramento County and all cities in the county.

The Workshop will provide a forum to discuss opportunities for collaboration on longterm preservation strategies for open space and agricultural lands lands, including what definitions of open space and agricultural lands may be most appropriate, resource values and where they are located. The intent of the Workshop will be to provide your Commission an opportunity to hear the speakers and discuss options with them, not just general concepts. The Commission may also wish to include discussion of the roles and expectations of the various cities and the County.

The recent presentation regarding collaboration between the State Department of Fish and Game, The Nature Conservancy and the City of Elk Grove is a good example of a creative approach to habitat preservation.

The outcome of the Workshop will be to provide your Commission with a quasi-regional leadership role in adopting local policies which motivate and guide future preservation efforts. Your Commission may do so by bringing these groups together and creating policies that define a vision of the County's open space in the future and how to help accomplish it.

## **Review of LAFCo Legislative Mandate**

Government Code Section 56377 guides development away from agricultural and openspace lands:

In reviewing and approving or disapproving proposals which could reasonably be expected to induce, facilitate, or lead to the conversion of existing open- space lands to uses other than open-space uses, the commission shall consider all of the following policies and priorities:

(a) Development or use of land for other than open-space uses shall be guided away from existing prime agricultural lands, in working landscapes or in open-space use toward areas containing non-prime agricultural lands, unless that action would not promote the planned, orderly, efficient development of an area.

(b) Development of existing vacant or non-prime agricultural lands for urban uses within the existing jurisdiction of a local agency or within the sphere of influence of a local agency should be encouraged before any proposal is approved which would allow for or lead to the development of existing open-space lands for non-open-space uses which are outside of the existing jurisdiction of the local agency or outside of the existing sphere of influence of the local agency. LAFCo has the opportunity to contribute to countywide considerations by shaping the form and path of growth through adopted policies. The draft policies reflect the mission of LAFCo as being one to influence and guide development from prime agricultural land, not to stop growth.

As you know, your Commission plays a role in regional planning issues by taking into consideration a wide range of land use and growth factors when acting on matters under your jurisdiction. LAFCo has broad statutory responsibility to facilitate planned, orderly, efficient patterns of urban development; preserve prime agricultural lands; and discourage sprawl. Your decisions must balance the competing needs for affordable housing, economic opportunities, public safety and the preservation of natural resources.

By making decisions about the extent of the geographic area over which a local government or special district may control planning, services provision and development, LAFCo may influence the extent and path of growth and development both locally and regionally. LAFCo should act as a filter for the timing and direction of new growth precipitating changes of Sphere or jurisdictional boundaries. Your Commission must weigh the needs and resources of each community, the regional implications, and impacts to environmental resources.

In fulfilling our mission, LAFCo has two opposing mandates which it must balance:

- (1) Provide land for orderly development and efficient service delivery;
- (2) Preserve and protect open space and prime agricultural lands.

## EXECUTIVE OFFICER'S RECOMMENDATION

Direct staff to proceed with Commissioner Tooker's proposal to convene a Public Workshop for the Draft Sacramento LAFCo Polices, Procedures and Guidelines Open Space and Prime Agricultural Land Preservation Policies for Evaluating Sphere of Influence and Annexation Proposals.
